The October meeting of the Tecumseh District Library Board was called to order at 5:30 PM by President, Lisa Hart.

Reading of the mission and vision statements

Approval of Minutes from the September 18, 2023 Meeting (see attached): After discussion, a few additions and corrections were made to the minutes. The minutes were approved as amended.
