The March meeting of the Tecumseh District Library Board was called to order at 5:34 PM by President, Lisa Hart.

Reading of the mission and vision statements

Roll call was taken. The Trustees present were Lisa Hart, Debbie Gilbey, Judy Prater, Carma Roesch, Dana Schumacher-Schmidt, Stacey Knepper and Taylor Williams. Also present were Library Director, Susan Bach, and Ginger Poczatek.

**Approval of Minutes from the March 21, 2023 Meeting (see attached):** The minutes were approved as previously distributed.

#### **Reports:**

- **Director's Report (see attached):** Susan Bach shared more details regarding her report. The new Reference Desk has arrived. The library will be closed on May 5, 2023 for Staff Development Day where they will focus on emergency situations. Tecumseh police officers will provide Run, Hide, Fight training.
- **Treasurer's Report (see attached):** Judy shared more details regarding the Treasurer's report. **Motion:** Carma Roesch moved to approve the report as presented. The motion was seconded and it passed.
- **Sunshine Report:** Dana Schumacher-Schmidt reported that the Sunshine Fund has a balance of \$105.00. Dana will make cookies using the favorite candies for staff during National Library Week which is April 23 -29. She will also get a gift card for Jennifer Crane for Administrative Professionals Day on April 27.
- **Executive Committee: (see attached):** The Executive Committee met on April 5, 2023 to discuss the library director evaluation process and the open Building & Grounds Liaison position; Debbie Gilbey volunteered to fill this roll. **Motion:** Stacey Knepper moved to nominate Debbie Gilbey for the Building & Grounds Liaison position. The motion was seconded and a roll-call vote was taken. Trustees Lisa Hart, Carma Roesch, Debbie Gilbey, Judy Prater, Dana Schumacher-Schmidt, Stacey Knepper, and Taylor Williams voted to approve the motion. No one opposed. Lisa Hart shared background information regarding the Director Evaluation process and provided a draft of the process for trustees to review. Susan Bach will set her goals for the coming year.

- Capital Improvements Committee: The new Reference Desk was purchased. The total cost of the desk was \$17,394.00, of which The Friends of TDL group donated \$8,000 toward the purchase. Director, Susan Bach will be meeting with a lighting contractor to get a quote for switching the lighting in the library to LED.
